

HRS Homework Policy 2025



Intent

- A. At HRS, we know that research shows that timely and appropriate homework has a positive impact on academic outcomes at both primary and secondary levels. The Education Endowment Foundation (EEF) findings show that homework can have an impact of +5 months of progress, if linked effectively to classroom instruction.
- B. In addition, it provides students with the opportunity to develop essential life skills such as time-management and self-discipline - essential skills for success beyond school.

1. Possible homework tasks

Our homework curriculum is intended to afford teachers the flexibility to select what and when certain independent tasks are most appropriate, so that homework is closely linked with classroom work.

The tasks may include:

- ★ Independent research
- ★ “Flipped learning” - preparation for material yet to be taught
- ★ Consolidation of classroom work
- ★ Rote vocabulary learning
- ★ Examination practice
- ★ Online adaptive platform tasks (such as Sparx or Educake)
- ★ Revision for assessments
- ★ Actioning feedback/rewriting assignments

2. Amount and frequency

* This is only a suggestion as subjects with fewer teaching hours may not be set as frequently.

** This does not include time for revision for mocks and exams.

Reading

- Years 7 and 8 receive fortnightly SparxReader homework - this is set by their Literacy lesson teacher.
- In addition to the above, we would expect all pupils to carry out private reading for at least 20 minutes every day. This can include fiction, non-fiction, articles etc.

6th Form: Years 12 & 13

A-Level students should plan for one hour of independent study for every hour they're taught in class. This will be in addition to the homework set by teachers.

3. Recording of and communication of homework

- Homework will be set on Classcharts. Explicit details for the expectation of the homework including how long they have to complete the homework and a due date will be included on Classcharts. KS5 - Independent study is an addition to homework and students should aim to complete an hour of independent work for each hour of lesson. Students are allocated 4 independent study sessions in the Sixth Form study area each week.

- Homework will be set with a reasonable deadline for completion - as a minimum this could be a 48 hour turnaround. This applies to KS3 and 4 only, KS5 may have shorter deadlines in light of the independent study guidelines.

4. Expectations

5. Possible barriers to timely homework completion

- **Lack of technology** - The Learning Zone is open every day during break and lunch for Homework Club.
- **No Printer** - Students will not be expected to print any sheets.
- **Difficulty completing tasks** - the students will have deadlines of at least 48 hours in which to contact their teacher to ask for support. The students could also utilise the Homework Club where 6th formers can assist.
- **No quiet space to work** - use the Learning Zone at lunchtime to complete homework tasks
- **SEND / learning needs** - Class teachers are trained to adapt their strategies for students with varying needs. Students are encouraged to speak to their class teachers to negotiate reasonable adjustments.
- **Takes more time than expected** - if you notice a student taking longer than the expected time on the homework, ensure you stop them and sign the work with a note for the teacher explaining they have spent the suggested time and were unable to complete the task.

6. Incompleted homework

In order to maintain fairness across the school and ensure all students are achieving their academic potential, it may be necessary to issue sanctions to students in the event that homework is not submitted. In the first instance, teachers will use their professional judgement to issue extensions or exemptions if there are extenuating circumstances.

Instance	Consequence	Actioned by
1	10 minute faculty detention	Class teacher
2	20 minute faculty detention and contact home	Class teacher
3	60 minute after school detention and contact home	Head of Department / Head of Faculty
Each instance will be logged on Classcharts to notify parents. For persistent incompletion of homework, the Head of Department/Faculty will refer the student to the Head of Year and the Pastoral Team who will escalate the sanctions in accordance with the school's behaviour policy.		

It must be noted that professional discretion will be used at all times to ensure the sanctions are proportionate and reasonable to the individual child.

7. Artificial Intelligence (AI)

- AI can be a helpful tool for students to explore ideas and research, but it should never be used as a substitute for completing the homework. Teachers will monitor the use of AI and students might be asked to redo the homework if AI has been deemed to have completed the homework for the student.

This document will be reviewed regularly in light of emerging research and students' needs.
